### **Informa Group Holdings Limited – GBP 1,250,000,000 Bridge Facility Agreement dated 24 July 2024 (the Agreement)**

1. We refer to the Agreement. This is a Transfer Certificate. Terms defined in the Agreement have the same meaning in this Transfer Certificate unless given a different meaning in this Transfer Certificate.
2. We refer to Clause 22.6 (Procedure for transfer) of the Agreement:
  - (a) the Existing Lender and each New Lender agree to the Existing Lender transferring to the New Lenders by novation, and in accordance with Clause 22.6 (*Procedure for transfer*) of the Agreement, the Existing Lender's rights and obligations under the Agreement and the other Finance Documents which relate to that portion of the Existing Lender's Commitment and participation in Loans under the Agreement as specified in Schedule 1;
  - (b) the proposed Transfer Date is 27 August 2024; and
  - (c) the Facility Office, address and attention details for notices of each New Lender for the purposes of Clause 29.2 (Addresses) of the Agreement are set out in Schedule 2.
3. Each New Lender expressly acknowledges the limitations on the Existing Lender's obligations set out in paragraph (c) of Clause 22.5 (Limitation of responsibility of Existing Lenders) of the Agreement.
4. Each New Lender confirms, in Schedule 2, for the benefit of the Agent and without liability to any Obligor, whether it is:
  - (a) a Qualifying Lender (other than a Treaty Lender);
  - (b) a Treaty Lender;
  - (c) not a Qualifying Lender.
5. If a New Lender comes within paragraph (i)(B) of the definition of "Qualifying Lender" in Clause 12.1 (Definitions) of the Agreement, such New Lender confirms that the person beneficially entitled to interest payable to that Lender in respect of an advance under a Finance Document is either:
  - (a) a company resident in the United Kingdom for United Kingdom tax purposes; or
  - (b) a partnership each member of which is:
    - (i) a company so resident in the United Kingdom; or
    - (ii) a company not so resident in the United Kingdom which carries on a trade in the United Kingdom through a permanent establishment and which brings into account in

computing its chargeable profits (within the meaning of section 19 of the CTA) the whole of any share of interest payable in respect of that advance that falls to it by reason of Part 17 of the CTA; or

- (c) a company not so resident in the United Kingdom which carries on a trade in the United Kingdom through a permanent establishment and which brings into account interest payable in respect of that advance in computing the chargeable profits (within the meaning of section 19 of the CTA) of that company.
6. Each New Lender that confirms that it holds a passport under the HMRC DT Treaty Passport scheme and wishes that scheme to apply to the Agreement, provides, in Schedule 2, its reference number and confirms the jurisdiction of its tax residency, so that interest payable to it by borrowers is generally subject to full exemption from UK withholding tax, and requests that the Company notify:
- (a) each Borrower which is a Party as a Borrower as at the Transfer Date; and
  - (b) each Additional Borrower which becomes an Additional Borrower after the Transfer Date,
- that it wishes that scheme to apply to the Agreement.
7. This Transfer Certificate may be executed in any number of counterparts and this has the same effect as if the signatures on the counterparts were on a single copy of this Transfer Certificate.
8. This Transfer Certificate and any non-contractual obligations arising out of or in connection with it are governed by English law.
9. This Transfer Certificate has been entered into on the date stated at the beginning of this Transfer Certificate.






